Processing framework Purpose and legal basis for processing

Video surveillance:

video surveillance systems are used for the reduction or prevention, prevention of crime, detection of crime, other serious violations, enforcement of house rights and protection of property.

Legal basis:

The processing finds its legal basis in publicly accessible areas in Art. 6 (1) lit. f GDPR. With regard to employees, the processing is additionally based on Section 26 (1) BDSG-Neu, Art. 6 (1) lit. f GDPR. The legitimate interest of the controller in the processing follows in all cases from the fact that the aforementioned processing purposes outweigh the minimal impairment of the data subjects associated with the processing and short-term storage for the data subject.

Internal bodies:

Warehouse management and IT

External bodies:

Contractual partners who have access to our video systems for evaluation, maintenance and fault analysis. These have been obligated in accordance with Art. 28 GDPR to handle the processing of the data on our behalf.

Duration of storage / deletion (according to Art. 18 GDPR)

As a rule, we do not store the video data for longer than 7 days (exception: in the case of a logged handover to investigating authorities). The data is deleted after the backup purpose has ceased to exist.

Your rights

Right to information: You have the right to obtain information from us about the processing of your personal data. (Art. 15 GDPR)

Right of rectification: You have the right to request that we correct any personal data relating to you that is inaccurate or incomplete. (Art. 16 GDPR)

Right to erasure: You have the right to request the erasure of your data if the conditions set out in Art. 17 GDPR are met. According to this, you can, for example, demand the deletion of your data if it is no longer necessary for the purposes for which it was collected. You can also request deletion if we process your data on the basis of your consent and you revoke this consent.

Right to restriction of processing: You have the right to request the restriction of the processing of your data if the conditions of Art. 18 GDPR apply. This is the case, for example, if you dispute the accuracy of your data. You can then demand the restriction of processing for the duration of the verification of the accuracy of the data.

Right to object: If your personal data are processed on the basis of legitimate interests pursuant to Art. 6(1)(f) GDPR, you have the right to object to the processing of your personal data pursuant to Art. 21 GDPR, unless the controller can demonstrate compelling legitimate grounds for the processing and the interests, rights and freedoms of the data subject are overridden, or the processing serves the purpose of asserting, exercising or defending legal claims.

Right to data portability: where data processing is based on consent or the performance of a contract and is also carried out using automated processing, you have the right to receive your data in a structured, commonly used and machine-readable format and to transfer it to another data processor. (Art. 20 GDPR)
